MINUTES Meeting of the Greenwood City Council Acting as the Local Board of Appeal & Equalization



April 7-21, 2022 | Excelsior Council Chambers, 339 Third Street, Excelsior, MN

CALL TO ORDER | ROLL CALL | APPROVE AGENDA

At 6:05pm on 04.07.22, Mayor Kind called the meeting to order.

Members Present: Mayor Deb Kind; Councilmembers Kristi Conrad (6:07pm), Bill Cook, Tom Fletcher, and Rob Roy Others Present: Assistant Administrator Shanda Wilhemy (04.07.22), Assessors Michael Smerdon, Melody Devine, and Joe Estlie

Motion by Roy to approve the agenda. Second by Cook. Motion passed 4-0.

Mayor Kind explained the meeting process and the Local Board of Appeal of Equalization (LBAE) heard and reviewed written appeals from those on the roster and those whose names were added to the roster at the convening meeting.

At 9:05pm on 04.07.22, Mayor Kind recessed the meeting.

At 9:06pm on 04.07.22, Mayor Kind reconvened the meeting to hear the appeal of Pady & Dennis Regnier.

At 9:10pm on 04.07.22, Mayor Kind recessed the meeting.

At 6:00pm on 04.20.22, Mayor Kind reconvened the meeting.

The assessor made a recommendation for each property on the roster. Each property owner in attendance was given the opportunity to respond to the assessor's recommendation. The LBAE discussed each appeal and made preliminary decisions regarding land and building values for the properties on the roster. Additional properties were added to the roster to preserve their right to appeal to the County Board of Appeal & Equalization.

Motion by Kind that the LBAE approves the final roster and final decision regarding 2022 land, building, and total values for 21560 Fairview Street. Second by Conrad. Motion passed 4-0-1 with Fletcher abstaining.
